

Opt-Out Option:

In accordance with the Virginia Board of Education Guidelines for Family Life Education (FLE), an “opt-out” procedure shall be provided to ensure communication with the parent or guardian for permission for students to be excused from all or part of the program. This option is available to parents and guardians at any time during the school year before the child’s FLE program starts.

The alternatives for a student opting out of FLE are as follows:

The student may complete a non-family life oriented unit of health study selected by the Health Teacher. This project will use an independent study format.

The work completed will be assessed in a manner that is consistent with the normal practice in the school.

Parents or guardians wishing to remove their child from any or all portions of the FLE program should complete the “Opt-Out Form” on the opposite side of this page. Parents should contact their child’s school principal with any questions.

Community Involvement:

The Fluvanna County Public Schools Wellness Committee annually reviews the school division Family Life Curriculum and instructional resources. This committee is comprised of parents, community members, and representatives from health care.

Family Life Standards of Learning

Third Grade:

- 3.1- The student will demonstrate a sense of belonging in group work and play.
- 3.2- The student will express what he or she likes about himself or herself to continue developing a positive self-image.
- 3.3- The student will become aware of the changes occurring in family life that affect daily living and produce strong feelings.
- 3.4- The student will give examples of healthy coping strategies for dealing with the feelings produced by changes in the family.
- 1.7 & 3.5- The student will identify and use correct terms for external body parts associated with reproduction and elimination.
- 3.6- The student will recognize that while all human beings grow and develop in a given sequence, rates and patterns vary with individuals.
- 3.7- The student will become aware that both a male and a female are necessary to have a baby.
- 3.8- The student will comprehend that the baby grows inside the mother’s body for nine months and then is born.
- 3.9- The student will describe the types of behavior that enable him or her to gain friends or to lose friends.
- 3.10- The student will practice safety rules in the home.
- 3.11- The student will demonstrate to others how to respond appropriately to good touches and how to handle inappropriate approaches from relatives, neighbors, strangers, and others.
- 3.12- The student will be conscious of how commercials use our emotions to make us want products.
- 2.3- The student will become aware that babies grow inside the mother’s body in a special place called the uterus.

Parental Review of FLE Curriculum

In accordance with the Code of Virginia for Family Life Education (Code 22.1-207.2), parents and guardians have the right to review the family life education program offered by their school division, including written and audio-visual educational materials used in the program. Parents and guardians also have the right to excuse their child from all or part of family life education instruction.

A complete copy of all printed materials and a description of all audio-visual materials shall be kept in the school library or office and made available for review during school office hours before and during the school year. The audio-visual materials shall be made available for review, upon request, on the same basis as the printed materials are made available. Parents and guardians are encouraged to make arrangements through their child's school to review Family Life Education (FLE) materials.

Code of Virginia Family Life Education: In 1987, §22.1-207.1 of the Code of Virginia was amended to direct the Board of Education to develop standards of learning and curriculum guidelines for a comprehensive, sequential family life education (FLE) curriculum in grades K through 12. From February 1987 to December 1987, individuals from public schools (including administrators and teachers), state agencies, parent groups, and not-for-profit organizations that provided family life services contributed time, resources, and expertise to help develop a report to submit to the Virginia General Assembly. The report Family Life Education: Board of Education's Response to House Bill No. 1413 included sections on the Board of Education guidelines for setting up a required FLE program, Standards of Learning objectives, and descriptive statements for grades kindergarten through 12, guidelines for training individuals that teach FLE, and for involving parents and community-based organizations in the local FLE program.

Each year when the General Assembly meets, they review the current law and pass legislation to add topics to the standards.

The program is abstinence based, meaning that as an educational or motivational component, it has as its exclusive purpose, to teach the social, psychological, and health gains to be realized by teenagers abstaining from sexual activity before marriage.

FLE Goals for Students in Special Education Classes

FLE goals for students in special education classes are the same as for students in general education; however, instruction involves a cooperative effort between special education and FLE teachers. Using the Individualized Education Program (IEP) process, the FLE curriculum can and should be modified and adapted to meet the individual needs of the student. FLE goals and objectives for students enrolled in special education classes are written in students' IEPs. Parents are encouraged to contact their child's teacher with any questions.
