Opt-Out Option:

In accordance with the Virginia Board of Education Guidelines for Family Life Education (FLE), an "optout" procedure shall be provided to ensure communication with the parent or guardian for permission for students to be excused from all or part of the program. This option is available to parents and guardians at any time during the school year before the child's FLE program starts.

The alternatives for a student opting out of FLF are as follows:

The student may complete a nonfamily life oriented unit of health study selected by the Health Teacher. This project will use an independent study format.

The work completed will be assessed in a manner that is consistent with the normal practice in the school.

Parents or guardians wishing to remove their child from any or all portions of the FLE program should complete the "Opt-Out Form" on the opposite side of this page. Parents should contact their child's school principal with any questions.

Community Involvement:

The Fluvanna County Public Schools Wellness Committee annually reviews the school division Family Life Curriculum and instructional resources. This committee is comprised of parents, community members, and representatives from health care.

Family Life Standards of Learning Ninth Grade:

- 9.1- The student will understand the human growth and development cycle.
- 9.2- The student will explain the importance of the family as a basic unit of society and his or her responsibility as a member of the family.
- 9.3- The student will recognize the development of sexuality as an aspect of the total personality.
- 9.4- The student will review and apply the decision-making process.
- 9.5- The student will review the nature and purposes of dating.
- 9.6- The student will realize the importance of setting standards for controlling sexual behavior and of postponing sexual relations until marriage.
- 9.7- The student will interpret the effects and prevention of sexual assault, rape (including date rape), incestuous behavior, and molestation.
- 9.8- The student will relate specific information on substance use and abuse to each stage of the life cycle.
- 9.9- The student will be able to explain the process of reproduction.
- 9.10- The student will demonstrate understanding of specific health issues, including the ability to conduct self-examinations
- 9.11- The student will demonstrate knowledge of pregnancy prevention and disease control.
- 9.12- The student will explain the transmission and prevention of the HIV.
- 9.13- The student will identify the effects of discrimination.
- 9.14- The student will begin to identify educational and career goals.

Parental Review of FLE Curriculum

In accordance with the Code of Virginia for Family Life Education (Code 22.1-207.2), parents and guardians have the right to review the family life education program offered by their school division, including written and audio-visual educational materials used in the program. Parents and guardians also have the right to excuse their child from all or part of family life education instruction.

A complete copy of all printed materials and a description of all audio-visual materials shall be kept in the school library or office and made available for review during school office hours before and during the school year. The audio-visual materials shall be made available for review, upon request, on the same basis as the printed materials are made available. Parents and quardians are encouraged to make arrangements through their child's school to review Family Life Education (FLE) materials.

Code of Virginia Family Life Education: In 1987. §22.1-207.1 of the Code of Virginia was amended to direct the Board of Education to develop standards of learning and curriculum guidelines for a comprehensive, seguential family life education (FLE) curriculum in grades K through 12. From February 1987 to December 1987, individuals from public schools (including administrators and teachers), state agencies, parent groups, and not-for-profit organizations that provided family life services contributed time, resources, and expertise to help develop a report to submit to the Virginia General Assembly. The report Family Life Education: Board of Education's Response to House Bill No. 1413 included sections on the Board of Education guidelines for setting up a required FLE program, Standards of Learning objectives, and descriptive statements for grades kindergarten through 12, guidelines for training individuals that teach FLE, and for involving parents and community-based organizations in the local FLE program.

Each year when the General Assembly meets, they review the current law and pass legislation to add topics to the standards.

The program is abstinence based, meaning that as an educational or motivational component, it has as its exclusive purpose, to teach the social, psychological, and health gains to be realized by teenagers abstaining from sexual activity before marriage.

FLE Goals for Students in Special Education Classes
